

# PRIMARY CARE PSYCHIATRY MEDICAL DIRECTOR JOB ANNOUNCEMENT

Santa Cruz Community Health (SCCH) began as a women's health collective in 1974 with the mission to improve the health of our patients and the community and advocate the feminist goals of social, political, and economic equality. Now, more than 45 years later, we serve that same mission as a nonprofit Federally Qualified Health Center operating two separate sites: the Santa Cruz Women's Health Center in downtown Santa Cruz serving women and children; and the East Cliff Family Health Center in Live Oak, serving everyone.

SCCH has a diverse patient population and an engaging and friendly work environment. Our caring and committed staff works as a team to fulfill our mission so that all our patients have access to comprehensive, quality health care.

#### **POSITION SUMMARY:**

Santa Cruz Community Health is a local leader in integrating mental health and substance use disorder treatment into the primary care medical setting. The Primary Care Psychiatry Medical Director advances access to psychiatric, behavioral health, and substance use disorder treatment services and ensures high quality care to SCCH patients. This role offers clinical expertise and leadership experience to SCCH leadership and providers in developing clinical programs, protocols, and services in a community health, primary-care setting. This role is full time with 25% leadership/management and 75% direct patient care and has direct reports. This role reports to the Chief Medical Officer.

#### CORE JOB RESPONSIBILITIES:

### ESSENTIAL FUNCTIONS INCLUDE BUT ARE NOT LIMITED TO :

#### LEADERSHIP DUTIES (10 hours/week; 0.25 FTE)

- Collaborate with clinical leadership to update, develop, and implement clinical guidelines and protocols on common mental health conditions, such as anxiety, depression, ADHD, insomnia, etc., including co-occurring substance use disorder
- Provide general and clinical supervision to Psychiatric Mental Health Nurse Practitioner (PMHNP), including chart review and performance evaluation

- Lead the development and management of SCCH psychiatry program including:
  - Promote psychiatry and behavioral health services within and outside of SCCH
  - Collaborate with SCCH Behavioral Health and Office-Based Addiction Treatment leadership to design services for patients including those with co-occurring substance use disorder and mental health illness
  - Educate clinicians on psychiatry-related topics
  - Collaborate with community partners and programs
- Collaborate with community psychiatrists on clinical quality & supervision of PMHNP
- Use data systems to design program improvements and measure impact on patient care and patient-oriented quality outcomes

# CLINICAL DUTIES (30 hours/week; 0.75 FTE)

- Provide direct patient care (in-person, telephonic, telehealth visits) with focus on psychiatric care, including substance use disorder treatment when indicated
- Deliver primary care, as needed (e.g. urgent care, preventive care, chronic disease management, etc.)
- Full primary care scope to be determined
- Productivity rate 2 pt/hr average across psychiatric care and primary care
- 24 hours direct patient care time; 6 hours clinical administrative time
