

# PSYCHIATRIC CARE COORDINATOR, TEMPORARY JOB ANNOUNCEMENT

### **POSITION SUMMARY:**

SCCH's Psychiatric Care Coordinator (PCC) assists all patients in need of psychiatry services by acting as a patient and program advocate and navigator. The PCC assists in developing psychiatry work flows and supports scheduling.

Further, the PCC addresses barriers to psychiatric care by providing advocacy and coordination of appointments and referrals, preparing charts for patient visits, assisting the mental health care providers with workflows, and serving as a strong and flexible member of a health care team. The PCC demonstrates exceptional critical thinking, clinical, patient and provider relations, organizational, and time management skills.
